## SHIN-NY CBO Whitepaper Released

### Critical Data: Supporting Community-Based Organization Information Exchange Under New York's New Medicaid Waiver

A critical component of improving the social determinants of health of Medicaid enrollees is the exchange of both health care data and social services data. New York State's 1115 Medicaid waiver demonstration, submitted to CMS in September of 2022, seeks to invest in "the inextricably linked health disparities and systemic health care delivery issues that have been highlighted and intensified by the COVID-19 pandemic." The waiver proposes the development of "a statewide data store [that] will provide the State with near real-time insights into waiver activities such as screenings and referrals" related to community-based organizations (CBOs).

NYeC, together with Manatt Health, undertook a study to better understand the challenges of data exchange between CBOs and the health care sector. Seventeen CBOs, providing a wide range of varying services, participated in an October 2022 roundtable related to CBO information sharing, the Medicaid waiver, and the SHIN-NY. Additionally, CBOs responded to two different surveys administered by NYeC. A smaller group of CBOs also shared insights during interviews with NYeC and Manatt Health.

## HEALTHeLINK Releases 2022 Report to the Community



HEALTHeLINK has released its 2022 Report to the Community. Highlights from the report include:

- With support from the Milbank Memorial Fund, HEALTHeLINK conducted a study to examine if population health analytics helped to improve care quality and efficiency in primary care practices enrolled in the Centers for Medicare and Medicaid Services' Comprehensive Primary Care Plus (CPC+) program.
- Addition of new offerings to help drive efficiencies and improve overall quality of care, including Emergency Department Summary Reports, which immediately generate specific queries for a predefined set of data when a patient has been registered at Erie County Medical Center's emergency department.
- Launch and expansion of new population health-related services to help create efficiencies for health plans, provide custom metric reporting, and community research support.
- More than 1.1 million clinical results, such as lab tests and radiology reports and images were delivered monthly. This marks a 16% increase over 2021.
- Patient record lookup which enables participating HEALTHeLINK providers to instantly access a consented patient's clinical record and obtain information such as test results, medication history, etc. totaled more than 8.2 million.
- Finally, in 2022 alone, the HEALTHeLINK team worked on a total of 83 different projects focused on improving the HIE foundation and enhancing the services offered to its participants.

## Rochester RHIO Working to Expand Community Health Indicators



Rochester RHIO is working in collaboration with Common Ground Health to develop new measures of community health using rational clinical data in the HIE. For the past several years, Community Health Indicators has provided a snapshot of rates for five key population health measures: smoking status, high blood pressure, diabetes control, adult obesity and pediatric obesity.

Through a project funded by NYeC, Community Health Indicators will expand to include measures for behavioral health, maternal health, and social determinants of health. Through this collaboration, measure specification and creation are aligned with regional population health improvement efforts and support 1115 Waiver planning.

Measures under consideration include:

- **Behavior Health:** Follow-up for mental health ED visit, Follow-up for substance abuse disorder ED visit, Depression Screening Follow-up
- **Maternal Health:** Prevalence of Cesarean Births, Severe Maternal Morbidity, Prenatal Care in the First Trimester
- **Social Determinants of Health:** Prevalence of social services needs (e.g., housing, transportation, food insecurity)

## Bronx RHIO Begins First Phase of Planning for SHIN-NY Inclusion of SDOH Data



Supported by funding from NYeC to all six QEs, Bronx RHIO is leading a statewide work group to develop functional requirements for ingestion, handling and reporting of Social Determinants of Health (SDOH) data gathered from assessment questionnaires where answers are not available through currently coded standards.

The pending 1115 Medicaid waiver and the pandemic have encouraged focus on health equity, driving the need to incorporate social data into the SHIN-NY and link it to the clinical data already in place to provide a more holistic view of health-related needs. However, unlike with clinical data where ICD-10 and other coding systems exist to standardize data from all sources, SDOH data standardization is in its infancy. Many national work groups have been working to create standards for several years, but there is still much inconsistency in the tools for data collection and interpretation of questions and answers about social needs.

The statewide Work Group is focused on identifying a common approach and requirements for ingestion, storage and interpretation of the various SDOH assessment tools that are and will be in use in New York State. We will leverage all existing standards from the Gravity Project and others, identify needs still to be met, and how to address them as new coded standards are approved. Each QE can utilize the requirements to set up its ingestion processes and data model to identify and report on SDOH needs in a standardized manner.
